When I wrote my January letter for The Visitor, I knew that unless we had a terrible winter storm, TBC's children and youth would give us another extraordinary Christmas gift in the form of a Christmas Eve program. Karen Dunne's writing and direction of "The Light in the Cradle" set the stage for a multitude of young people to sing, dance, and share in word. They drew our eyes to Jesus, the Light of the World. We thought it would go that way, but it seemed better to wait and write about it after the fact! Congratulations and thanks to Karen and other adults who assisted!

When I wrote my January letter, I knew Christmas and the days after would be special. I thought I would bask in the afterglow of Christmas and

enjoying a few more days of our youngest son's visit. I would get my 2020 calendar filled in with things I knew were already planned. I thought my father would be home from the hospital and listening to the country-music CD we bought him for Christmas.

When I wrote my January letter, I didn't know that the last days of December, 2019, would be special because they were the last days I shared with my sweet father. A minor fall in early November seemed to have plunged him into advanced congestive heart failure. I flew to Georgia on Thursday, Dec. 26, and found him very weak but still his usual good-natured self. He cracked jokes with everyone who came in the room on Friday. The therapists helped him sit up for a little while and even stand for a moment. We went to bed Friday knowing that things looked promising for rehab. But, during the next night, I began to notice that my father wasn't cracking jokes with people anymore. His sleep was restless and there was some disorientation. On Sunday he grew lethargic, and tests eventually showed that problems that caused his first ICU stay had returned with a vengeance. Back into ICU we went. Doctors confirmed that treatments were decreasingly effective and, even with drastic measures, we would only have my father with us for a few days.

Because my father had written a letter—not a January letter—but a letter telling us what he wanted if he faced an incurable illness, we knew that the time had come to ask for only comfort measures. Use of a bi-pap machine in the ICU lowered his CO2 level to the point where he was lucid again. That gave us time to be sure he agreed with the plan for just keeping him comfortable. All of us had opportunities to tell him again how much we loved him, and he was able to tell us he loved us and was proud of us all, too. We moved him to the hospice New Years Eve and my mother stayed with him overnight. The staff was excellent, and we were thankful for their expertise in keeping him comfortable and for the beautiful surroundings that were a comfort to us all after days in the hospital. New Years Day at 7:20 a.m., he died.

When I wrote my January letter, I knew God would have new things for us in 2020. I quoted Isaiah 43:19-21: "I am about to do a new thing; now it springs forth...to give drink to my chosen people, the people whom I formed for myself so that they might declare my praise. "I didn't know that that for me and my family, there would be a huge change: We would be learning to live with my father only in our memory. I knew my father had written down what he wanted in his funeral, but I didn't remember that it was for me to do most of the funeral. I knew God is faithful, but I didn't know if I had the strength to give my father this final gift. I wrote everything out so that if I broke down and couldn't pull it back together during the service, Jim could read what I had written.

When I wrote my January letter, I knew TBC is a great congregation. Now, I know what your strong

support means in a difficult time! I made it through the funeral service, and I know it was because of your prayers and support and that of other family and friends. My mother and brother and I have been united throughout the whole process with common goals. I SO appreciate your understanding of my absence. Staying in Georgia until mid-January helped me get past the numbness that followed the first intense grief. I also was able to help my mother, who is quite capable, get started on the many details that must be handled.

When I'm writing this February letter, I know the new things I wrote about in the January letter are already in the making. We had great Annual Meetings on Sunday. Thank you to all those who stayed to the happy adjournment! We have a great set of servant-leaders, and I am happy to be back in the daily swing. I know that I am in a new phase of life. Having lost a parent, I recognize in a new way my own mortality. I know, as I knew when I wrote for January "Each year presents many precious moments." My exhortation is the same: "Let us not waste a single one!"

Please remember Pastor Daniel and Khinsoe Moe and I in prayer while we travel to Burma Feb. 21—March 6. On Feb. 23, Dr. Jim Kelsey will preach, and, on March 1, his Associate, Rev. Jerrod Hugenot will preach and lead in Communion.


